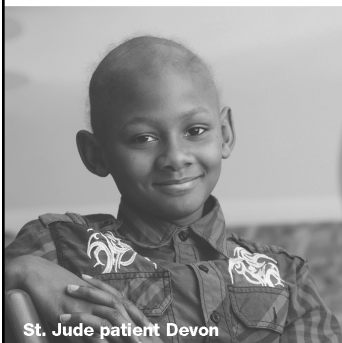

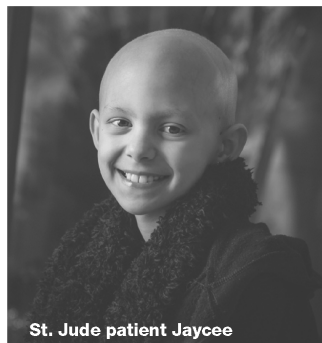

President's Message

I want to wish all our Lakes of Delray residents a happy and healthy new year. As we embark on 2023, we will be celebrating the fortieth anniversary of the Lakes of Delray. Hopefully, the next forty years will be even better than the first forty years.

As we turn forty, the need for repairs to maintain our facilities has grown. The infrastructure jobs the Board has been discussing are now scheduled. Work on the decking is scheduled to commence on February 1st and be completed on March 10th for a total of six weeks. The lighting project will commence on March 1st and will end on May 5th for a total of ten weeks and the replacement of the spa will commence on April 1st and will be completed on June 15th for a total of

sixteen weeks. There will be some flexibility in this schedule, and it is possible that the work on the spa will commence earlier than April 1st.

During construction there will be days that the pool and pool deck will be closed particularly during the lighting portion of these jobs. There will need to be trenching of the pool deck during the lighting part of these projects and based on how many trenches we have on any different day, there will be the need to close the pool and pool deck for safety reasons. I have made it very clear to Zarco Construction as well as to our Property Manager, Ron Nolan, and to our Supervisor of Maintenance, Anthony Napoli, that I want them to try to keep the pool and pool deck closures limited to as few days as possible. We will not know how many days the pool and pool deck will be closed until the construction starts; however there may well be closures that last many weeks at a time.

Some of you have asked me why we are starting the construction during the season and there are two reasons for this. First, with inflation the cost of these jobs has risen over a quarter million dollars over the past year and we do not want to incur any further price increases, and secondly, in construction like this, you must permit it to take place when the construction company is available to do it and Zarco has the manpower to do these jobs now. The permit process in Palm Beach County is running six to eight weeks and Zarco Construction is in the process of obtaining the permits so work can start on schedule.

I hope to see everyone at our semi-annual free hotdog night on Wednesday January 11th from 5 PM to 8 PM on the pool deck. I am happy to announce that The Mad Dogs, starring Becky Weinberg, will be returning to perform for us. This band was here for our July 4th party, and they were very well received. Becky Weinberg is the wife of Bruce Springsteen's East Street Band drummer, Max Weinberg, and Becky lit up this place in July and everyone was blown away by her great personality and interaction she had with those in attendance. The band performs a mixture of classic rock from many famous rock groups. The leader of this band owns an upscale recording studio in Deerfield Beach, and they will be bringing a professional sound system with them, and the volume of the music will be very loud as it was back in July. This is the only band which we have ever permitted to really turn up the volume and they will be permitted to do so again on January 11th. The band will be performing under the decking near the multi-purpose room so, if you are a resident who normally likes to sit under the decking, and you are not a fan of loud music, please consider sitting on the far side of the pool by the lake.

Amanda has many shows and new events planned throughout 2023 and I hope to see all of you at them enjoying yourselves. Together, let's make 2023 the best year ever for the Lakes of Delray.

PICTURE ID REQUIRED

LOD Residents,

LOD Picture ID is required to be shown to the clubhouse guard and scanned each time you enter the clubhouse. Unfortunately, when we permit exceptions to this policy for people who "forget" their ID, the number of folks who forget tends to increase dramatically with time, and then there are those who blatantly abuse the exceptions. For this reason, we have a no exception policy. Please make sure you have an updated ID with barcode on the back and if your ID has gone missing, see Kate in the office.

Your personal driver's license, photocopy of your ID, or photograph of your ID will not be accepted as proof of residency. A physical LOD picture ID is the only acceptable form of proof of residency. Renters and companions should pay attention to the expiration date on your card and update accordingly in advance. Owners with renters in their units have legally passed their privileges to their renters and thus their ID cards are invalid for entry to the Clubhouse for the duration of the lease period.

Please cooperate with the guards as they are required to apply this Board adopted policy. Questions or concerns about Clubhouse policies should not be argued or addressed with the guards. They should be directed to the management office. This reasonable policy is easy to follow and makes LOD just a little bit more secure. Thanks for your help in making it so.

The Board hopes everyone enjoyed the holiday and New Year's season. We attended the most recent December meeting of the Alliance and the Sheriff's office reminded us to keep our cars locked at night wherever we go.

- As seasonal population increases, so does car theft. They also reminded all of us to be very cautious about constant internet scams. The scammers are getting more and more creative and we all need to be more defensive. There is no free lunch.
- Attorney Gerstin provided a summary of 2022 Legislative and case law updates.
- The Legislature is meeting in January with Florida insurance as their premier legislative issue. As we know, insurance is a big problem here and partial as well as other more broad considerations are being reviewed
- Of special note is that as time goes by, there seems to be more clarity to the Condominium Safety Laws coming out of the horrific Surfside tragedy. This law will probably not be repealed but be made more palatable to prevent HOAs and Condominiums from suffering unreasonable financial hardships.
- Regarding association elevator door mechanism safety mechanisms, refurbishment must be completed by 12/31/2023.
- Regarding two story building reserve study is due 12/31/2024. More details are available about requirements for our Watersedge buildings. Think engineer/architect- certification will be required as of the current process.
- The LOD board will not comment whatsoever on how any associations should respond and you need to discuss all pertinent issues regarding compliance with this legislature with your board, property manager or your attorney - probably all three.
- The next New Resident Meet and Greet will be held Wednesday, February 8 at 1:30 PM in the downstairs multipurpose room. A great way to meet a new neighbor would be to invite them to the Meet and Greet.

Dog Decorum: Etiquette Tips for Dog Owners

Always Pick Up After Your Dog:

Picking up waste from your dog is by far the #1 dog etiquette rule, because dogs' waste can spread disease, is harmful to the environment, and not picking it up is just plain gross. Don't aggravate other dog owners or neighbors walking outside – pick it up and toss it away in your HOA dumpster. If your dog has an accident in the catwalk, elevator or common walking path, it is your job to clean it up.

Control Their Barking:

There is no bigger pet peeve for your neighbors than a dog that barks uncontrollably. Usually this occurs when someone knocks on the door, or they hear someone in the hallway that startles them. But barking can also happen when you're away, because they're sad, bored, or just miss you. If you have received noise complaints from neighbors, take it seriously and figure out what is causing your dog to bark.

Keep Them on a Short Leash in the Community and in Your Condo Building:

I love my dog, you love your dog; but not everyone in the LOD is a dog lover. Residents may be afraid, allergic or just don't like dogs. Keeping your dog on a leash (preferably a short one) is the courteous thing to do, but it is also the law in Palm Beach County. It's also important when coming into entryways, catwalks, common areas, and elevators that your leash is short (i.e. 3- 4 feet) and that you don't let your dog charge into spaces or jump on residents. Not every dog wants to meet your dog. When you are in a situation where you cannot avoid other dogs, ensure your leash is kept short. That way no interactions between dogs can happen. If a dog happens to show that he wants space, the best thing to do is keep moving past the dog. Stopping and allowing your dog to fixate will only make the situation worse. If you know other dog owners who have dogs that are friendly and they like to meet: that is great!

Play by the “Common Area” Rules:

LOD has common areas which are shared spaces where both residents and dogs interact. It's not a personal playground, so play by the rules of the condo and be a good neighbor. When walking around the community counter-clockwise, your dog should be on your right side along the grass (common area). The grass area and tall hedges on your left (in front of the condo parking lots) are private property. It's dangerous to walk your dog along the tall hedges because aside to being exposed to pesticides, they may end up in a fight with a wild goose, squirrel, or raccoon.

Avoid Wandering:

Always keep an eye on your dog to make sure they don't wander or run onto private property. As you walk them, keep them close to you, especially when you are talking on your cell phone.

Friendly Reminder - The Lakes of Delray is a NO Pet Community:

All Service and ESA dogs must be registered with the LOD Property Management Office prior to entry into the premises. Dog owners must provide to the Property Manager the following documents (required by Florida State law): **Florida Mental Health Care provider prescription/letter for the ESA dog or certification/letter qualifying the service dog, Palm Beach County dog license along with current rabies vaccination paperwork.** **Dogs without these qualifying documents may be treated as a pet for purposes of LOD policies.**

When walking your support animal please carry the pets ID with you. Thank you.

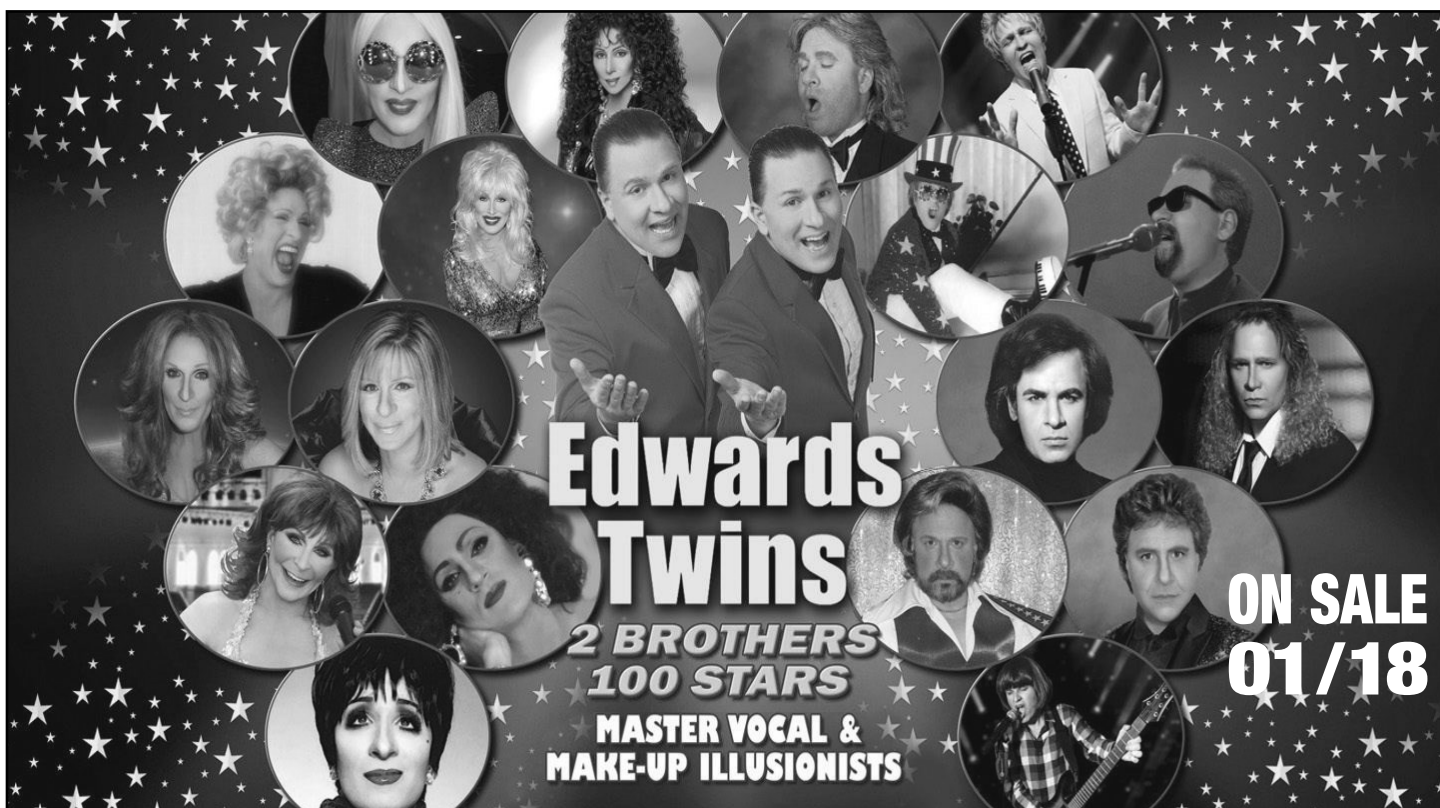

MINUTES

The Lakes of Delray, Inc. held its Board of Director's Meeting at 15055 Lakes of Delray Boulevard, Delray Beach, Florida 33484, on Wednesday, November 9, 2022. Present were: President Bob Berger, 1st Vice President Ed Simon, 2nd Vice President Dave Passman, Secretary Jayne Kulyassa, Director Rita Noce, Director Susan Heiferman, Director Jessica Krulfeifer, Director Harry Brudka, and Community Manager Ron Nolan

Not Present: Treasurer Lonnie Aronson

The meeting was called to order at 10:00 am by Bob Berger, who then led the attendees in the Pledge of Allegiance. Secretary Jayne Kulyassa declared that a quorum exists.

Verification of the Associations not present: Ashland G, Watersedge H, Witney B, and Wintney Manor C.

President Bob Berger moved to approve the minutes of the November 9th, 2022 meeting; Susan Heiferman seconds.

CORRESPONDENCE: Jayne Kulyassa

No Report

PRESIDENT Bob Berger:

As we turn forty years old as a community, the need for repairs to maintain our facilities has grown. The infrastructure jobs the Board has been discussing are now scheduled. Work on the decking is scheduled to commence on February 1st and be completed on March 10th for a total of 6 weeks. The lighting project will commence on March 1st and will end on May 5th for a total of 10 weeks, and the replacement of the spa will commence on April 1st and will be completed on June 15th for a total of 16 weeks. There will be some flexibility in this schedule, and it is possible that the work on the spa will commence earlier than April 1st.

We were told that the permit process in Palm Beach County is running six to eight weeks and Zarco Construction is in the process of obtaining the permits so work can start on schedule. However, we were just informed by Zarco yesterday that they were just told that the Board of Health needs to be involved in the permit process, so this adds another agency that needs to be involved which may add a few weeks to obtaining the required permits. That will push the schedule I just read to you back a few weeks. The contract, which was written by our attorney and then sent to Zarco to fill in their numbers, is now back with our attorney for final approval, and we hope to have the contract signed by next week.

There will need to be trenching of the pool deck during the lighting part of these projects and based on how many trenches we have on any different day there will be the need to close the pool and pool deck for safety reasons. I have made it very clear to Zarco Construction as well to Ron and Anthony that I want them to try to keep the pool and pool deck closures limited to as few days as possible, but we will probably experience pool deck closures of at least several weeks or more at a time during the lighting part of these jobs. We will not know how many days the pool and pool deck will be closed until the construction starts. For those of you who have been to the pool over the past week, you will have noticed that some of the bushes have already been cut down, which is needed for the lighting project. After the light poles have been installed, the bushes will be replaced by wooden planters that we will build in-house.

Some of you have asked me why we are starting the construction during the season and there are two reasons for this. First, with inflation, the cost of these jobs has risen over a quarter million dollars over the past year and we do not want to incur any further price increases. Secondly in construction like this, you must permit it to take place when the construction company is available to do it and Zarco Construction has the manpower to do these jobs now. Both Ron and Anthony's main priorities over the next few months will be the construction jobs. They may not be able to get to all your requests as quickly as they normally do. Please be patient with any requests you have for either of them.

- 1) The Lakes of Delray assessment letters were mailed two weeks ago, and many came back with the wrong address. We have found that many non-resident owners have moved over the years and have not informed their management companies or our office of their change of address. Hopefully, all the Associations know how to get in touch with their residents so they can collect the assessment.
- 2) Comcast is causing us a myriad of problems. We are once again experiencing many problems with pixelization and picture freezing. I have asked anyone who is having any problem with Comcast to document the problem and either drop it off at the office or send it to us via the Boards email, which is Board.LOD@gmail.com. The documentation must have your name, your street address (not your building name, which is meaningless to Comcast because they only use addresses) your apartment number, and the phone number associated with your account. The channels you are having a problem with, and the date and time of the problem. I often joke reading is not a requirement to live in the Lakes of Delray. I think I received 15 or 16 emails this week with documentation and all but two did not have all the information that I requested. Several of the documentation from the past week have only had your building's name and not the street address. I have looked them up for you, but going forward, if you do not have the proper

documentation, I will return the email to you for correction. We are asking you to also call Comcast to complain and set up a repair appointment and we will forward all the documented information to Comcast. They in return have set up some repair appointments and some have worked. Some of you who have had repair appointments have informed me that you are still having the same problems. I have asked our Comcast representative to get me answers this week as to how they are going to fix the problems. We heard from Comcast yesterday and the email I received said "Good Morning Bob, I have re-escalated this issue with our technical operations and network maintenance teams. A technical supervisor has indicated to me that he will be coming by the property today to investigate. I provided him with all of the information that you have provided me as far as addresses and a description of the issues," I wrote back to our Representative and asked him to have that technician stop by the office to meet with Ron and that did not happen".

If the situation continues, we will once again get our attorney involved. Now, this is very important. We found out last week that the free fiber optics hook-up ends on December 31st. We have already had two extensions of this deadline and Ron is trying to get another extension, but I am not counting on that happening. Then I found out on Friday that if you do not switch over to fiber optics, you will lose your service when they remove the old boxes that are located outside your buildings. So, if you have not yet had your fiber optics hooked up, please call for an appointment before December 31st. I do not want to see anyone lose their service.

- 3) Smoking area. We have had complaints about secondhand smoke on the pickleball courts and we are looking for alternatives. We can not legally stop smoking altogether in our community.
- 4) As I promised at the last Board meeting, I have the details for the room rentals for parties or meetings, which will start in January. The ballroom rental will be \$250, the large cardroom will be \$200 and the other rooms will be \$150. All room reservations will require a \$50 refundable cleanup deposit. The availability of the rooms will be coordinated by Kate and Amanda in the office. Certain rooms will have limited days of being available for rental. Please check in the office for availability before you schedule an event or party.
- 5) Covid testing...we had 71 residents tested for Covid yesterday bringing the total number tested to 4,268. Anthony Terzo is working on getting a new three-in-one test that tests for Covid, RSV, and Flu. We will let you know via an email blast if and when that test becomes available. He has also been getting requests for more antibody testing and he will get back to me if and when he can do that for us.
- 6) Reminder: no ID's needed if you have a ticket to a show.
- 7) Christmas tree photo shows Boca West has beautiful lights at their entrance, in white & blue.
- 8) Traffic...residents driving the wrong way on a one-way in front of the Clubhouse. Please be aware this is a one-way street.
- 9) Back in September one of our light posts on the tennis

court was struck by lightning and the quotes to repair ranged from \$8,000 to \$11,000. If you remember I said recently that we want to get away from saying. "This is always the way we have done things." In the past, we have not taken advantage of our residents' talents, especially in the field they worked in for their living in their pre-Lakes of Delray days. I found out that Charlie Kaplan was an electrician and I asked him to see Ron. He helped Ron and Anthony make the repairs to the light pole wiring in-house which saved us \$8,000 - \$11,000. Charlie, we thank you so very much for your help.

- 10) If you attended Stan Latopolski's retirement party you know that we gave Stan a gift certificate to the Casa Yebel resort on Sanibel Island. The resort had been severely damaged by hurricane Ian. We asked for a refund from the resort and we will be sending Stan to another location.
- 11) As President. It's not my job to criticize people. We need to treat people equally, but something rather disgusting happened in the pool the other day that I need to address. I was standing in the pool and a guy came over and started blowing his nose in the trough of the pool. "I said excuse me that's disgusting. Sir, you can not do that!" He said, "Oh Ya, I can do that there is a filter system in here. At that point, I identified myself and said there is no filter system, there is just a drain. I said the water only goes in and out at the trough. I said you cannot do that. He said too bad, you do it your way and I'll do it my way. I went out to get the guard, but by the time I got back, he was gone. If this happens again, yell out to everybody on the pool deck what this guy is doing.

So we are looking into the area at the hammock to add an exercise trail, benches, a rock garden, and a meditation space. I look forward to hearing from you.

COMMUNITY AFFAIRS: Dave Passman

We attended the most recent December meeting of the Alliance and the Sheriff's office reminded us to keep our cars locked at night wherever we go. As the seasonal population increases, so does car theft. They also reminded all of us to be very cautious about constant internet scams. The scammers are getting more and more creative and we all need to be more defensive. There is no free lunch. Attorney Gerstein provided a summary of 2022 Legislative and case law updates. The Legislature is meeting in January with Florida insurance as their premier legislative issue. As we know, insurance is a big problem here. Partial, as well as other more broad considerations, are being reviewed. Of special note is →

that as time goes by, there seems to be more clarity to the Condominium Safety Laws coming out of the horrific Surfside tragedy. This law will probably not be repealed, but be made more palatable to prevent HOAs and Condominiums from suffering unreasonable financial hardships.

Regarding association elevator door mechanism safety mechanisms, refurbishment must be completed by 12/31/2023. The two-story building reserve study is due 12/31/2024. More details are available about the requirements for our Watersedge buildings. Think engineer/architect-certification will be required as to the current process. The LOD board will not comment whatsoever on how any associations should respond and you need to discuss all pertinent issues regarding compliance with this legislation with your board, property manager, or your attorney - probably all three. The next New Resident Meet and Greet will be held Wednesday, February 8th at 1:30 PM in the downstairs multipurpose room. A great way to meet a new neighbor would be to invite them to the Meet and Greet. As always, the board and volunteers continue to work to make the Lakes of Delray a great place to live!

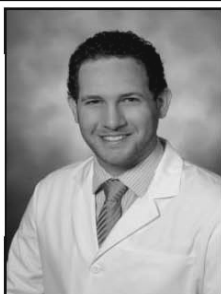

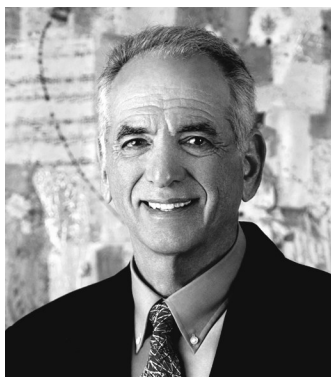

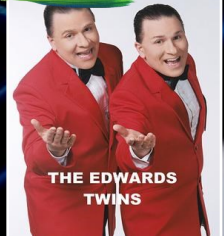
